Sealed bids will be received by the Mayor of the Town of Notasulga at the Town Hall, 76 Main Street, Notasulga, Alabama (mailing address: P.O. Box 207, Notasulga, Alabama 36866) until 4:00p.m. on May 19, 2025. Bids must be clearly marked to show the above reference bid No. 2025-05-10. No price shall include federal, state, or local taxes. No errors shall be corrected after the bids are opened. The town reserves the right to accept or reject any and all bids or any portion thereof. Bids are made for a period of work to be performed to be performed until work is complete.

All items must meet the Alabama Department of Transportation Standards Specifications for Highway Construction dated 2025.

Bids will be opened and considered at 7:00p.m. on May 19, 2025.

- Wearing surface 424A-346 to be placed as directed by the Mayor or his designee at a rate 165#/sy, 20 feet wide. 200 tons has been added to be wearing 1.6 miles and used as spot leveling as directed by the Mayor (estimated quantity 1,750 tons).
- Project from AL Hwy 81 to city limits on Gerald Robinson Dr., also known as Hwy 59.
- Tack Coat equivalent to 405A-000 at a rate directed by the Mayor or his designee not to exceed 1,500 gallons.
