NOTICE IS HEREBY GIVEN that the City of Russellville shall receive and open sealed bids for the purchase of one (1) or more items of Plant Mix - FOB Plant at Russellville City Hall located at 304 N Jackson Ave., Russellville, AL 35653 at **11:00 AM CST, Wednesday, October 29, 2025**. Bid specifications are available at the Russellville City Hall located at 304 N Jackson Ave., Russellville, AL 35653, the City's website (<http://www.russellvilleal.org>), and the Alabama League of Municipalities website (<http://tprc.ua.edu/services/rebuild-alabama-act-municipal-bids/>).

Sealed bids will be received by the City Clerk at the Russellville City Hall in Russellville, Alabama until 11:00 AM, CST, Wednesday, October 29, 2025, and then opened as soon thereafter as possible. Bidders and any others are invited to attend the bid opening.

THE INVITATION PACKAGE

The invitation package for **Inquiry RC-2025-01 Hot Plant Mix – FOB PLANT**, includes: this Invitation to Bid and Bid Submittal Form which includes Bid Specifications and the Bid Sheet to be used in the submittal of all bids. Bidders should verify that they have received all pages of the invitation package. If there are any omissions, the bidder should contact Belinda Miller at (256) 332-6060 to request missing pages. It is the responsibility of the bidder to make this request in sufficient time to prepare and submit the bid in time for the bid opening.

Bidders should carefully read and comply with all parts of the invitation package, including all attachments and/or any addendum.

PREPARING AND SUBMITTING BIDS

All bids must be typed or hand written in ink on the attached Bid Submittal Forms. **The completed Bid Submittal Form shall be placed in front of and separated from all other documents included in the bid packet, such that it will be the first document viewed upon opening the bid packet.**

Bids submitted in pencil and bids not submitted on the Bid Submittal Form will **not** be considered. Only information contained on the Bid Submittal Form or herein requested or required will be considered in evaluating bids.

The Bid Submittal Form and all required documentation shall be forwarded to Russellville City Hall in a sealed envelope with **Inquiry RC-2025-01 Hot Plant Mix – FOB PLANT**, clearly marked on the outside of the envelope. Envelopes containing a "no bid" shall also include the words "NO BID" on the outside of the envelope. Facsimiles and e-mails will not be accepted. Bids submitted by "Express/Overnight" services must be in a separate inner envelope or package sealed and identified as stated above. All bids must be received in the office of the Mayor prior to the bid opening. Bids received after the deadline will be returned unopened.

BID SPECIFICATIONS

The specifications for **Inquiry RC-2025-01 Hot Plant Mix - FOB PLANT** is attached hereto and at (<http://www.russellvilleal.org>) and (<http://tprc.ua.edu/services/rebuild-alabama-act-municipal-bids/>). Any use of specific names and/or model numbers in the attached specifications is not intended to restrict the bidder or any seller or manufacturer but is included solely for the purpose of indicating the type, size, and quality of materials, product services, or equipment considered best adapted to the use of the City of Russellville. Any reference to the Alabama Department of Transportation (ALDOT) Standard Specifications for Highway Construction shall mean the current non-metric edition.

BIDDER QUALIFICATIONS

All bidders and program participants must be in compliance with any applicable federal, state, county and municipal laws, regulations, resolutions and ordinances, including but not limited to, licensing, permitting, and taxation requirements. All bidders should be prepared to submit evidence or documentation as proof that they are properly licensed and permitted under any applicable laws upon request. Such evidence or documentation may be submitted with the bid.

All bidders shall provide proof of compliance with the E-Verify requirements of Alabama's Immigration Law (Ala. Code § 31-13-1 et seq., as amended by Act No. 2012-491). **All bidders must be on the ALDOT list of approved contractors and material suppliers.**

BID AWARD

The City of Russellville will serve as the awarding authority for all bids and will award all contracts at a regular meeting of the Russellville City Council. Any and all bids submitted in compliance with this invitation to bid shall be considered, and award will be made to the lowest responsible bidder meeting bid specifications as determined by the awarding authority in compliance with Alabama law. All factors contained in each invitation package will be evaluated in determining the successful bidder, and any omissions of the stated requirements may be cause for rejection of the bid submitted. The awarding authority reserves the right to reject any and all bids, to waive any informality in bids, and to accept in whole or in part such bid or bids solely at its discretion. The City of Russellville reserves the right to purchase materials (FOB Plant) from other suppliers based on the lowest cost for materials hauled to a given jobsite. This determination will be based on the total hauling costs, including the cost of fuel, equipment, employees, and materials. The City of Russellville also reserves the right to purchase materials (FOB Plant) from other suppliers if, for any reason, the lowest bidder is unable to supply the material to The City of Russellville.

The bids are valid for one (1) year from October 29, 2025, to October 29, 2026, but may be extended up to two (2) additional years by mutual agreement between the City of Russellville and the contractor

CONTACT REGARDING BIDS AND INVITATION

Contact initiated by a potential bidder with any city official or city employee shall only be as specifically set out in this invitation to bid. Any questions related to the bid or the City Bid Program shall be directed to the City Clerk in writing under the procedures set out in this Invitation to Bid. Additionally, a bidder may contact the **Street Department in writing to request an appointment to review bid specifications following the bid opening. However, there shall be no communication with any city official or city employee regarding this bid between the date of this invitation and the date of bid award.** Any other contact with a city official or employee initiated by a potential bidder regarding this bid between the date of this invitation and the date of bid award shall be deemed as an attempt to unduly influence the bid award and shall be grounds for rejection of the bid submitted by the bidder initiating such other contact.

BID SPECIFICATIONS
HOT PLANT MIX - FOB PLANT

I. Specifications:

A. The Bituminous Materials shall meet the requirement of Section 405 and 424 of the Alabama Department of Transportation Standard Specifications for Highway Construction, current edition, and any applicable revisions or special provisions issued since that date. Test Reports on the items listed below will be required upon request by the Street Superintendent.

II. Requirements:

- A. The successful bidder shall furnish the City of Russellville Street Department with a unit price per ton F.O.B. plant for the following Bituminous Materials:

PRICES SHALL BE ON AN AS NEEDED BASIS.

- B. The City of Russellville requests the successful bidder to have the capability of delivering at a minimum rate of 100 tons per hour daily.
- C. The orders for Bituminous Materials shall be placed by the Russellville Street Department at various times within the effective dates of the bid documents.
- D. Each item will be awarded separately based on the lowest responsible bidder. The successful bidder shall make the quantity of materials ordered available to the Russellville Street Department through F.O.B. Plant within a reasonable time after the order is placed. This time period should not exceed twenty-four (24) hours except in unusual circumstances. If the vendor fails to make the materials available, F.O.B. Plant within 24 hours, the Russellville Street Department reserves the right to cancel the order and award the vendor, submitting the next lowest acceptable bid, the order. Bidders are not required to bid on all items. The City of Russellville reserves the right to purchase asphalt (FOB Plant) from other suppliers based on the lowest cost for materials hauled to a given jobsite. This determination will be based on the total hauling costs, including the cost of fuel, equipment, employees, and materials. The City of Russellville also reserves the right to purchase asphalt (FOB Plant) from other suppliers if, for any reason, the lowest bidder is unable to supply the material to The City of Russellville.
- E. Weight tickets must be furnished to cover each delivery with the applicable street name listed on each ticket.
- F. Invoices for material provided by the successful bidder shall be mailed to:
City of Russellville, P.O. Box 1000, Russellville, AL, 35653.
- G. Bituminous Asphalt Adjustments shall apply to this bid. Payment for all Bituminous Materials shall be adjusted according to changes to the asphalt index supplied by the Alabama Department of Transportation. The base index used for asphalt adjustment calculations shall be the index for **October 2025**. The asphalt adjustment shall be calculated as per ALDOT specifications. The successful bidder shall furnish a mix-design for all Bituminous Materials sold to The City of Russellville for the purpose of calculating the asphalt adjustment.
- H. Reclaimed Asphalt Shingles (RAS) shall not be allowed in any bituminous plant mix item.
- I. Recycled Asphalt Mix (RAP) shall be limited to a maximum of 10% in any bituminous plant mix wearing layer items and shall be limited to a maximum of 15% in all other bituminous plant mix items.
- J. This bid shall be effective for one (1) year from **10/29/2025** through **10/29/2026**. If additional tonnages are added to this contract, the time limit may be extended up to two (2) additional years at the discretion of the Engineer. Any extension of this contract requires mutual agreement by the City of Russellville and the Contractor. However, the City of Russellville reserves the right to cancel and rebid this contract at any time after one (1) year from the original awarding date if it is in the best interest of the City of Russellville to do so.
